1. POSITION OVERVIEW

The Gardener Operator is responsible for performing the tasks and duties as assigned with the aim of achieving a standard of presentation of the parks, and reserves in accordance with the objectives and requirements of the Council.

2. DUTIES & RESPONSIBILITIES

2.1 Plant Operation

- Operate machinery of medium to high skill level as required associated with maintaining City Parks and Reserves. Including but not limited to Trucks, Backhoes, Loaders, Mini Skid Steer, Skid Steer, Water Cart, Excavator, Spray Equipment and ride on lawn mowers.
- Assist with movements of material to parks, ovals, facilities and playgrounds.

2.2 Tree Pruning and Mulching

 Complete tree pruning, removal and safe transportation to Tree assets to encourage tree growth, shape and meet guidelines and requests for sightlines, hazards and clearance

2.3 Tree & Shrub Planting

Assist in implementation of annual tree planting programme and Street Tree
Strategy to ensure Trees/Shrubs are planted to City specifications, staked, tied,
watered and maintained through the establishment period.

2.4 Mulching

 Implement annual mulching programme to parks, ovals, facilities and street trees with the utilisation of machinery.

2.5 Open Areas Management

 Complete customer service requests and work tickets to ensure open areas, verges, footpaths and natural areas are clear of vegetation through means of spraying, slashing and pruning.

2.6 Litter

 Collect all litter and hazardous material prior to completing works and dispose of in an appropriate manner.

2.7 Turf Presentation and Pest Eradication

- Identify weeds and pests and use appropriate methods of control, i.e. through mechanical means or use of chemical control measures.
- Undertake visual inspections of turf and advise Leading hand if fertilising required. Undertake fertilising of Ovals and Parks as required, using appropriate machinery.

 Assist Turf Maintenance Officers with turf renovations of parks, ovals and facilities as required and requested.

2.8 Technical

- Report reticulation problems within lawns and gardens promptly to Leading Hand.
- Assist with construction projects and major maintenance works as instructed.

2.9 Mowing and Brush Cutting

- Maintain presentation of open spaces, verges, drains etc, keeping weed growth to a minimum, by operating various mowers and machinery.
- Maintain presentation of parks, ovals and surrounds, by mowing whipper snipping and edging as scheduled.
- Any other instruction or duty, including maintenance, as required by Parks and Gardens Maintenance Supervisor.

2.10 Health & Safety

Employees are responsible for ensuring that:

- All tasks are undertaken with the full understanding of the officer's obligation to take reasonable care to ensure personal safety and health at work and that of other persons in the workplace.
- They comply with all City policies and procedures relating to safety
- Utilise the City's procedure for WHS Communication, Consultation and Issue Resolution.
- They will not misuse or damage any equipment provided in the interests of safety or health
- Observe all safe working practices as directed by the supervisor
- Use and maintain protective equipment correctly
- Report ALL accidents and incidents (including near-miss) arising in the course of work to direct line manager / supervisor ASAP and then complete the Accident Incident Report form as soon as reasonably practicable within 24 hours where possible.
- Report all hazards using the Hazard Notification Form.
- Other roles and responsibilities outlined in the WHS Management at the City of Karratha: Roles and Responsibilities.

3.1 Judgement and Problem Solving

- Ability to work under minimal direction either alone or in a team environment.

- Previous experience with garden maintenance and the use of associated plant and equipment.

- Developed communication skills to enable them to effectively provide advice to other employees, higher level staff, clients, suppliers and members of the public.
