- 1. **Guardianship:** I confirm that I am 18 or over and the legal guardian of the child(ren) registered to participate in the Colour Run on 15th November 2024
- 2. Safety Rules: I agree that my child will participate in the Colour Run in accordance with the specific safety rules clearly explained by staff at the beginning of the Colour Run.
- **3. Colour:** I understand that participating in the Colour Run is a potentially hazardous activity where the coloured powder will be thrown at and around my child during the event. However, I understand that the powder is not harmful to people, animals or plant life.
- **4. Risk of Injury:** I understand that participation in the event involves inherent risks, including but not limited to physical injury, cuts, scrapes, bruises, sprains, strains, dehydration, and heat exhaustion. I acknowledge that these risks are greater than those encountered in everyday life.
- **5. Health and Safety:** Participants are required to follow all safety rules and instructions provided by event staff. All participants must behave appropriately, respecting fellow participants, volunteers, staff, and property. Adherence to these safety and behaviour guidelines is essential, and failure to comply may result in denial of participation.

- **6. Fitness:** Participants must be in a good state of health and fitness and that there is no medical reason whatsoever that could be regarded as a restriction on or an impediment to my exercise workout. I acknowledge that the Colour Run is suitable for participants of all abilities and that obstacles can be bypassed if needed. As the legal guardian, it is my responsibility to assess my child's physical fitness to participate in the event. I understand the physical demands of the activity and acknowledge the risk of injury. Should there be any concerns about mine or my child's ability to safely complete the course, I will consult a healthcare professional before the event and notify the organisers of any significant health issues that could affect participation.
- 7. Rules and Regulations: I agree to abide by all rules and regulations established by the City of Karratha and/or its employees.
- 8. Safeguarding: Parents/carers are to be reminded that they are responsible for their child/children at the event at all times
- **9. Photography:** There will be staff members photographing the day. Images may be used for any purpose, including but not limited to, promoting the event for the City of Karratha on social media, websites, marketing materials, and other publications. Please advise staff prior to the event if you would like you or responsible participant/s to be excluded from such material.
- **10. Weather:** Remind children and their carers to bring appropriate clothing for outdoor weather, hot conditions and for exercising. i.e. wear a sunhat, apply sun cream, drink plenty of water and wear appropriate footwear.
- **11. Personal Property:** I acknowledge that during such times I am on the premises (or its surrounds) both my property and myself shall be at my own risk and I will not hold the City of Karratha (or its employees) liable for any personal injury or loss of property however caused.
