DECLARATION OF INTERESTS (NOTES FOR YOUR GUIDANCE) (updated 13 March 2000)

A member who has a **Financial Interest** in any matter to be discussed at a Council or Committee Meeting, which will be attended by the member, must disclose the nature of the interest:

- (a) In a written notice given to the Chief Executive Officer before the Meeting or;
- (b) At the Meeting, immediately before the matter is discussed.

A member, who makes a disclosure in respect to an interest, must not:

- (c) Preside at the part of the Meeting, relating to the matter or;
- (d) Participate in, or be present during any discussion or decision-making procedure relative to the matter, unless to the extent that the disclosing member is allowed to do so under Section 5.68 or Section 5.69 of the *Local Government Act 1995*.

NOTES ON FINANCIAL INTEREST (FOR YOUR GUIDANCE)

The following notes are a basic guide for Councillors when they are considering whether they have a **Financial Interest** in a matter. I intend to include these notes in each agenda for the time being so that Councillors may refresh their memory.

1. A Financial Interest requiring disclosure occurs when a Council decision might advantageously or detrimentally affect the Councillor or a person closely associated with the Councillor and is capable of being measure in money terms. There are exceptions in the *Local Government Act 1995* but they should not be relied on without advice, unless the situation is very clear.
2. If a Councillor is a member of an Association (which is a Body Corporate) with not less than 10 members i.e. sporting, social, religious etc), and the Councillor is not a holder of office of profit or a guarantor, and has not leased land to or from the club, i.e., if the Councillor is an ordinary member of the Association, the Councillor has a common and not a financial interest in any matter to that Association.
3. If an interest is shared in common with a significant number of electors or ratepayers, then the obligation to disclose that interest does not arise. Each case needs to be considered.
4. If in doubt declare.
5. As stated in (b) above, if written notice disclosing the interest has not been given to the Chief Executive Officer before the meeting, then it **MUST** be given when the matter arises in the Agenda, and immediately before the matter is discussed.
6. Ordinarily the disclosing Councillor must leave the meeting room before discussion commences. The **only** exceptions are:
 - 6.1 Where the Councillor discloses the **extent** of the interest, and Council carries a motion under s.5.68(1)(b)(ii) or the *Local Government Act*; or
 - 6.2 Where the Minister allows the Councillor to participate under s5.69 (3) of the *Local Government Act*, with or without conditions.

INTERESTS AFFECTING IMPARTIALITY

DEFINITION: *An interest that would give rise to a reasonable belief that the impartiality of the person having the interest would be adversely affected, but does not include an interest as referred to in Section 5.60 of the 'Act'.*

A member who has an **Interest Affecting Impartiality** in any matter to be discussed at a Council or Committee Meeting, which will be attended by the member, must disclose the nature of the interest;

- (a) in a written notice given to the Chief Executive Officer before the Meeting; or
- (b) at the Meeting, immediately before the matter is discussed.

IMPACT OF AN IMPARTIALITY CLOSURE

There are very different outcomes resulting from disclosing an interest affecting impartiality compared to that of a financial interest. With the declaration of a financial interest, an elected member leaves the room and does not vote.

With the declaration of this new type of interest, the elected member stays in the room, participates in the debate and votes. In effect then, following disclosure of an interest affecting impartiality, the member's involvement in the Meeting continues as if no interest existed.

1 OFFICIAL OPENING

Cr Long acknowledges the traditions of the Ngarluma people, on whose land we are gathered here today.

2 PUBLIC QUESTION TIME

The following questions were taken on notice at the August 2019 Ordinary Council Meeting. Responses to the questions are listed below:

1. Will the councillors apply the precautionary principle and resolve at the City of Karratha Council meeting on 16 September 2019 to commit the whole of the City of Karratha to a target of zero carbon emissions (Excluding the use of offsets) by 2025?

Councillors informally discussed this matter at the Sept 2019 Briefing Session. While no decision was made, Councillors indicated that they felt that the issue of carbon emissions targets was a Federal Government matter not one that Local Governments have control or influence over. Council is currently reviewing and revising its Environmental Sustainability Plan. This plan, which will be released to the public in draft form for comment prior to formal consideration/adoption by Council, will outline the City's plans and actions in relation to environmental sustainability. The Mayor has written to Mr Slee advising him of Council's discussions and encouraging him to review and comment on the Environmental Sustainability Plan when it is released.

2. Will the councillors apply the precautionary principle and resolve at the City of Karratha Council meeting on 16 September 2019 to limit human exposure to man-made RF radiation to a maximum of 10 micro watts/square metre in all public and recreational spaces, at all Council facilities, and in all other areas in which the Council can exercise a public health regulation in the city of Karratha?

Councillors informally discussed this matter at the September 2019 Briefing Session. While no decision was made, Councillors indicated that the issue of appropriate radiation levels within a community is a Federal Government issue and not an issue that the City has control/influence over hence it would be inappropriate for the City to set a limit on this matter. The Mayor has written to Mr Slee advising him of Council's discussions on this matter and advised him of the appropriate Federal Authority to raise this matter with should he wish to take the matter further.

This table shows that Council is currently in a surplus position of \$43.6m, a positive variance of \$3.4m compared to the budgeted surplus position of \$40.2m, which reflects timing differences for projects and processing of depreciation.

The restricted balance referred to in the preceding table and throughout this report comprises of Pilbara Underground Power (PUPP) Service Charges levied in 2014/15, which are subject to the 10-year instalment option offered by Council.

Current Assets increased by 41.74% from June to July, primarily due to an increase in accounts receivable after levying 2019/20 rates. Current Liabilities decreased by 50.28% compared to June due to a decrease in accounts payable, also due to end of financial year processing. Non-Current Assets increased slightly by 0.07% and is attributable to capital expenditure on Property and Infrastructure projects. There has been no change to Non-Current Liabilities.

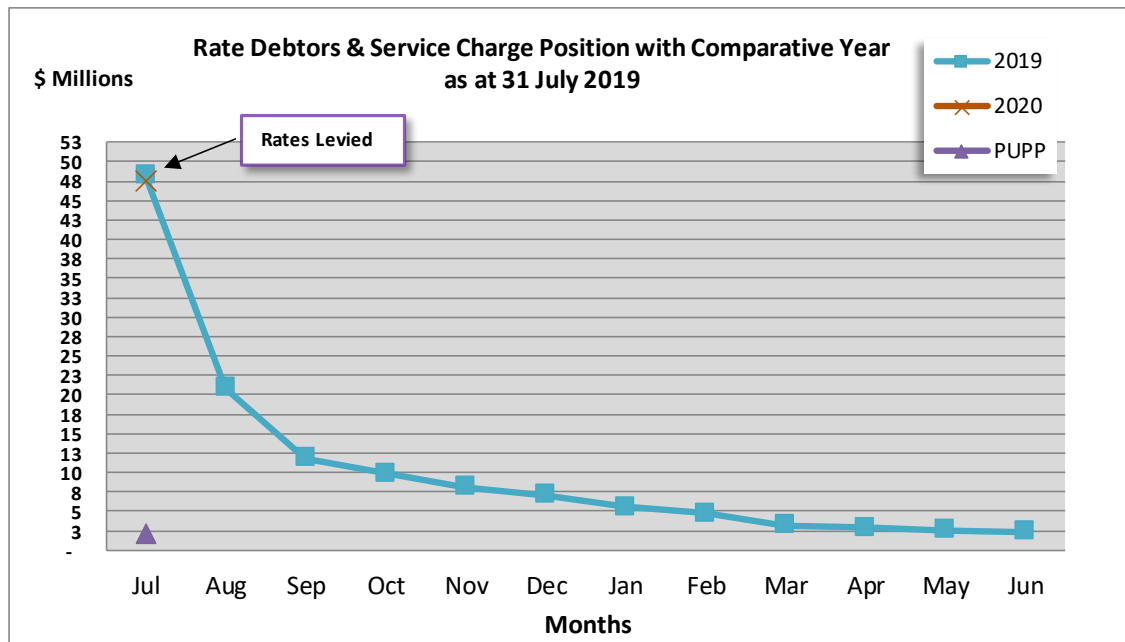

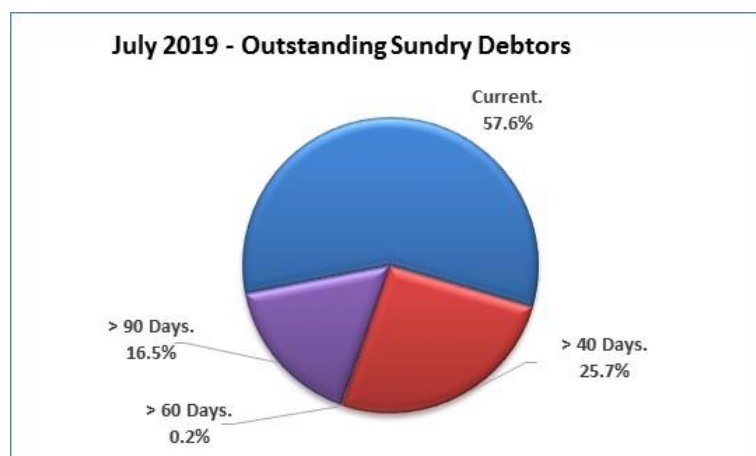
Rate Notices were issued on 22 July 2019 and the 1st instalment is due on 26 August 2019. \$1,265,810 has been collected to date representing a collection rate of 2.6% during the month.

There was a slight increase from June 2019 of 2% in the PUPP Debtors balance. PUPP payments have now been received on 99.5% of properties, and of those paid 97.7% have paid in full with 2.3% paying by instalments.

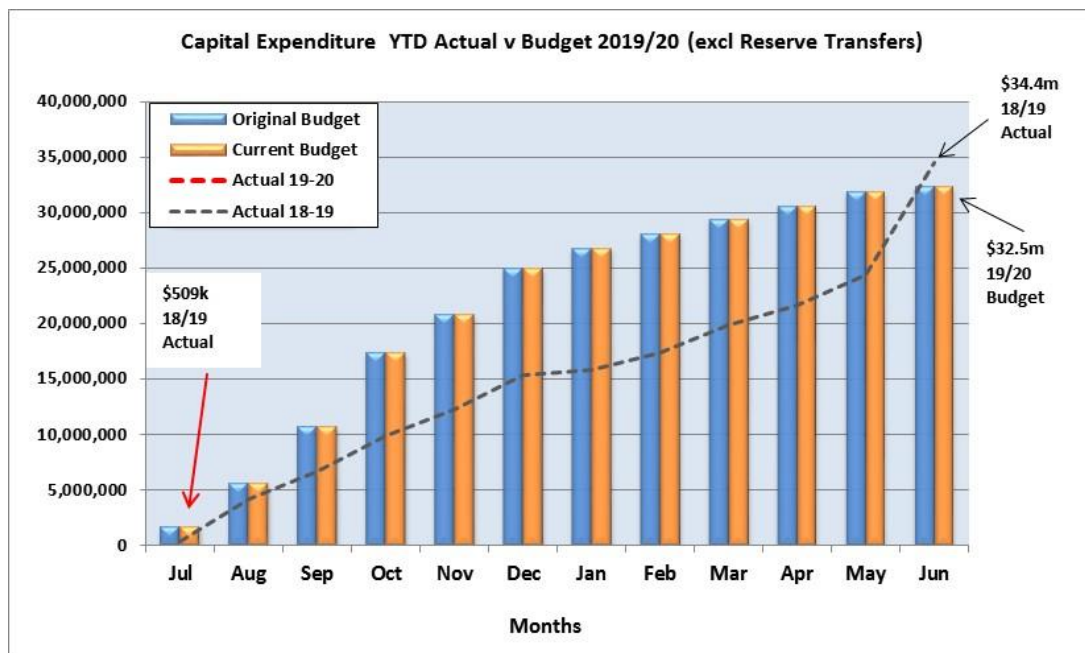

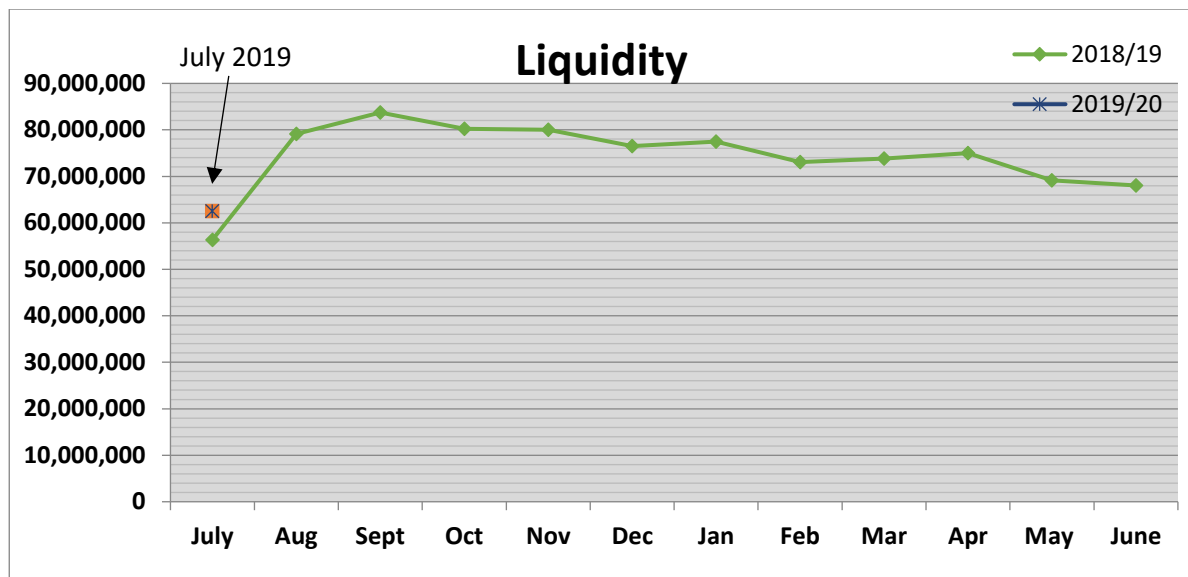
The balance of all Term Deposits includes interest accrued to 31 July 2019



The Reserve Bank cash rate (overnight money market interest rate) lowered the cash rate on 3 July 2019 from 1.25% to 1.00%. The Municipal funds held with Westpac Bank are currently earning 0.37% interest on balances between \$1m and \$5m in the everyday account and amounts greater than \$5m will earn 0.47%

During July, Council had a total of \$12m maturing in Municipal and Reserve investments, and funds were used to cover expenditure.

The liquidity graph for 2019/20 demonstrates a slight decrease in liquidity from June, primarily due to payment of accounts payable.



As part of Council’s investment strategy, reserve funds were used to purchase a commercial property ‘The Quarter’ in June 2017. The following table provides a summary of all income and expenditure for The Quarter for the current financial year:

LEVEL OF SIGNIFICANCE

Financial integrity is essential to the operational viability of the Council but also as the custodian of community assets and service provision. An ability to monitor and report on financial operations, activities and capital projects is imperative to ensure that financial risk is managed at acceptable levels of comfort.

The ability for the City of Karratha to remain financially sustainable is a significant strategy for a region that is continually under pressure from the resources industry, private enterprise and State Government obligations for the ongoing development of infrastructure and services.

COUNCILLOR/OFFICER CONSULTATION

Executives and Management have been involved in monthly reviews of their operational and departmental budgets and notifying the Financial Services team of trends and variances arising from their operational areas.

COMMUNITY CONSULTATION

No community consultation is required.

STATUTORY IMPLICATIONS

In accordance with the *Local Government Act 1995* and *Local Government (Financial Management) Regulations 1996*, a Statement of Financial Activity is required to be presented to Council as a minimum requirement.

Section 6.4 of the *Local Government Act 1995* provides for the preparation of financial reports.

In accordance with Regulation 34 (5) of the *Local Government (Financial Management) Regulations 1996*, a report must be compiled on variances greater than the materiality threshold adopted by Council of \$50,000 or 10% whichever is the greater. As this report is composed at a program level, variance commentary considers the most significant items that comprise the variance.

POLICY IMPLICATIONS

The Council's financial reporting is prepared in accordance with Accounting Policy CF1. This is reviewed periodically to ensure compliance with legislative and statutory obligations.

FINANCIAL IMPLICATIONS

The report represents the financial position of the Council at the end of July 2019 with a year to date budget surplus position of \$40,276,952 (comprising \$39,471,655 unrestricted surplus and \$805,297 restricted surplus) and a current surplus position of \$43,636,051 (comprising \$42,830,754 unrestricted surplus and \$805,297 restricted surplus). The restricted balance comprises PUPP service charges levied in 2014/15.

PURPOSE

For Council to consider supporting an application to the State Government in relation to the 2020/2021 Community Sport and Recreation Facilities Fund (CSRFF).

BACKGROUND

The State Government through the Department of Local Government, Sport and Cultural Industries (DLGSCI) provides funding to community organisations and local governments to develop sport and recreation infrastructure. This fund consists of three streams; forward planning grants (projects that exceed \$500,000), annual grants (projects up to \$500,000) and small grants (projects up to \$200,000).

The CSRFF guidelines allow for applicants to request up to 50% of the total project cost as a development bonus in certain situations.

The development bonus is assessed against the following criteria:

- Location – regional, remote or growth areas;
- Co-location of sports and facilities;
- Sustainability – water savings, energy reductions; and
- Increased participation – new users, increased participation of existing users, special interest groups, minority user groups.

As part of the application process, all applications must be endorsed and prioritised by the Local Government Authority prior to being submitted to the DLGSCI.

Council has endorsed a number of projects seeking external funding previously and have been successful with their applications including:

- \$375,000 Kevin Richards Memorial Oval (KRMO) change room redevelopment 2019/2020;
- \$250,000 Karratha Bowling Club Green Shade Upgrade 2016/17; and
- \$800,000 for the design and construction of Tambrey Pavilion.

Applications for the current round of grants are due in September 2019. Project that will be considered include new playing surfaces, floodlighting, change rooms/ablutions and sports storage.

Officers have reviewed Council's Long Term Financial Plan (LTFP) regarding proposed projects for completion in 2020/21 that are eligible for CSRFF funding.

On review of the current LTFP, the sports lighting upgrade at KRMO is the only project that will meet the required stage of planning to be eligible for funding – which is construction ready during 2020/21 financial year.

Securing funding to undertake the sports lighting upgrade at KRMO will complement previous funding received through CSRFF for the KRMO change room redevelopment, and other works planned for the site.

In 2018 the City undertook a major sports lighting audit which included a physical review of every sports light system across the municipality. The report detailed:

- Assessments of installation;
- Assessments of structural condition and photo documentation;
- Distribution board audits;
- Electrical and surge protection audits;
- Measurements of system life spans;
- Compliance to sports lighting standards and fitness for purpose;
- Option analyses for future system installations – upgrades to LEDs; and
- Cost estimates and forecasts for works.

Following this Council was presented with a six year sports lighting works plan which was endorsed at the December 2018 Ordinary Council Meeting. This Resolution also required Officers to pursue external funding opportunities to progress each annual program.

The 2020/21 Sports Lighting Upgrade schedule includes a complete system replacement at the KRMO, as well as design and construction of suitable lighting for the basketball courts and firefighting running track to extend their usability to night time use. This is consistent with the current plan for the broader redevelopment of KRMO.

The lighting upgrade has been estimated to be \$1,755,000 and Officers are able to request up to 50% funding via the CSRFF (\$877,500). This is 10% more than the City's LTFP, which budgets for only 40% to be externally funded, with the remaining 60% to be funded by Council.

LEVEL OF SIGNIFICANCE

In accordance with Council Policy CG-8 Significant Decision Making Policy, this matter is considered to be of moderate significance in terms of financial expenditure.

COUNCILLOR/OFFICER CONSULTATION

Internal consultation regarding the Works Plan has taken place between the City’s Community Projects, Recreation Facilities and Building Maintenance departments.

Consultation has also taken place with the Regional Manager of the Department of Local Government, Sport and Cultural Industries who oversees the applications from the North West region.

PURPOSE

For Council to consider the findings of the pre-feasibility analysis in relation to the development options for Lot 7020 Sharpe Avenue, Karratha.

BACKGROUND

Lot 7020 Sharpe Avenue is located at the primary entrance to Karratha's City Centre at the southern end of Sharpe Avenue, across the road from the Red Earth Arts Precinct. The lot was created through the Karratha City Centre Revitalisation and has a total land area of 4,564m². It adjoins a much larger vacant lot 7018 on the western boundary which has an area of 9,241m². Both lots are owned in Freehold by LandCorp.

LandCorp has previously attempted to sell the land parcels on the open market. However, it has been unable to secure a purchaser with plans to develop the land in a manner that reflects the significance of the site as a defining entry point to the City Centre.

Following discussions between the City and LandCorp, the City entered a 6-Month exclusive period for the purpose of undertaking preliminary due diligence and feasibility on the potential to develop a high quality, mixed use project on the site. The primary purpose of this was to establish how the City might be able to work with LandCorp to attract investment which would deliver a development outcome consistent with the expectations of the Karratha City Centre Masterplan.

RFF Consultants were engaged to progress due diligence and feasibility on behalf of the City on this site and their final report is provided as an attachment. The scope for the report requested;

- Determination of Cultural Infrastructure need,
 - Museum
 - Art Gallery
 - Exhibition Space
 - Local history and cultural centre; and
 - Film laboratory and recording studio
 -
- Determination of commercial infrastructure need,
 - Retail – fashion, florist, specialty, technology

- Bar and restaurant
 - Short stay accommodation; and
 - Entertainment outlet
- Risks, opportunities and processes and mitigation strategies,
 - Concept development on order of probable cost, and
 - Management model and operating forecasts.

The key findings of their report indicate:

- Significant demand for additional accommodation (both short-stay and residential) linked to forecast economic growth in the City of Karratha;
- The opportunity to further explore the viability of new cultural and community infrastructure; (eg. Museum, Art Gallery, Exhibition space, cultural centre)
- Locating tourism visitor services within city centres can increase visitation and therefore viability of these services in regional communities;
- The size and narrow width of Lot 7020 is a limiting factor for development, particularly when car parking requirements are factored in. A wider Lot 7020 would enable a better development outcome;
- The overall project feasibility is challenged by the overall cost of any development in Karratha, market sentiment and access to adequate finance;
- The capacity to attract private investment to develop the project is strongly associated with the ability to obtain large scale commitments to lease or purchase a final development outcome.

In summary, whilst the market conditions remain challenging in the 'current day', the forecast growth in coming years could provide the right environment to deliver a feasible project which is of the scale and quality suitable as the primary entrance statement into the Karratha City Centre alongside the Red Earth Arts Precinct.

Based on these findings the report recommends a focus on the following to move the project forward:

- Work with LandCorp to attract private investment through an expression of interest (EOI) to market, which includes the City as a potential project facilitator in the following ways;
 - leveraging its capacity and local knowledge to engage with major potential end tenants/ purchasers of product;
 - confirming interest in either purchasing/ leasing a subdivided parcel of land or large tenancy within a final development which could provide the space for new or relocated community infrastructure
 - considering a capital contribution to the project which delivers adequate community benefit.

Officers have considered the consultant's report and, presuming that there is interest from Council in continuing to progress with the project, suggest that the following indicative program for the progression of the project:

Prior to the commencement of construction, there would be numerous occasions for the Council and the local community to have input into the proposed development, including providing input into the appropriateness (or otherwise) of the City being involved with this project.

LEVEL OF SIGNIFICANCE

In accordance with Council Policy CG-8 Significant Decision-Making Policy, this matter is of moderate significance in terms of social, economic and cultural issues.

There is likely to be an ongoing commitment of internal resources and presently unbudgeted expenditure to progress forward as a project facilitator for the development of the land.

If the project does proceed, it is likely to become a significant matter for the Council's consideration.

COUNCILLOR/OFFICER CONSULTATION

Internal consultation has been undertaken with the Executive and Councillors have been briefed on the outcomes of the feasibility investigations.

The City has maintained regular communication with LandCorp throughout the feasibility investigations.

COMMUNITY CONSULTATION

No community consultation is required at this stage. Detailed community consultation/engagement will be required if the proposal is to proceed.

STATUTORY IMPLICATIONS

If the project is to proceed with City involvement it is highly likely that the matter will be considered as a Major Land Transaction. Under the provisions of the Local Government Act, Major Land Transaction and Major Trading Undertakings require the development of a detailed business plan that must be publicly advertised for a minimum of six (6) weeks with

all comments that are received on the proposal being considered by the Council prior to any commitment to proceed with the transaction.

POLICY IMPLICATIONS

There are no policy implications.

FINANCIAL IMPLICATIONS

Nil at this stage but there are likely to be additional internal resources required to progress the project if this is the future direction of Council.

CONCLUSION

The future development outcome of Lot 7018 and 7020 will have a defining impact on the visual amenity and activation of Karratha's City Centre. To date, the City has worked proactively with LandCorp to enable the ongoing development and build out of the revitalised City Centre.

The Lot 7020 Project Pre-Feasibility Analysis report has identified that there is a genuine opportunity for the City of Karratha to collaborate with LandCorp through an open EOI process to test private sector interest, where the City can express its capacity to contribute to a feasible and desirable development outcome.

If supported by Council, this report can now be used to develop the next steps in the development of this project.

2. **DEVELOPS** a more detailed scope/specification for the proposed community elements of the 7020 project;
3. **Continues to ENGAGE** with LandCorp and the private sector regarding options for the progression of the project; and
4. **NOTE** that the next steps for this project will be presented to Council at the January 2020 Ordinary Council Meeting.

PURPOSE

For Council to consider making a request to the Minister for Planning to approve the expenditure of \$232,566 as cash-in-lieu of public open space funds to contribute to implementing the Kevin Richards Oval Masterplan and an option for expending the remaining \$621,267 cash-in-lieu funds held by the City.

BACKGROUND

Western Australian Planning Commission (WAPC) Policy DC 2.3 requires subdividers to cede 10% of the gross subdivisible area of a land subdivision for public open space (POS).

If the WAPC forms the view that it would be acceptable for a subdivider to make a cash-in-lieu contribution in lieu of ceding land for POS, it will allow a cash payment to be made to the local government. Any such cash-in-lieu contribution is then held in trust by the local government. These Trust funds cannot be expended unless the Minister for Planning has granted approval.

Between 1996 and 2011, as part of clearing conditions of subdivision approval, the City has received cash-in-lieu contributions from seven subdivisions across the suburbs of Millars Well, Nickol, Baynton and Baynton West. The land from where the cash-in-lieu funds have been collected is shown on the plan at Attachment 1. These suburbs are now all established and all have existing POS areas. The cash-in-lieu contributions are in addition to the land in each of these suburbs that has been ceded and developed for POS.

Cash-in-lieu contributions generate interest while held in trust. The original cash-in-lieu contributions, the interest generated and the total funds now held in trust as cash-in-lieu of POS is summarised in the table below:

In accordance with *Planning Bulletin No.21 (April 1997) – Cash-in-lieu of Public Open Space*, cash-in-lieu of POS funds need to be spent in areas in proximity to the subdivisions from where they have been collected. The Bulletin states cash in-lieu funds must be used for development to which the public has access.

Cash-in-lieu funds may be used in the following manner:

- For the purchase of land for parks, recreation grounds or open spaces generally, in the locality in which the subdivision is situated;
- In repaying loans raised by the local government for the purchase of such land;
- With the approval of the Minister for Planning, for the improvement or development as parks, recreation grounds or open spaces generally of any land in the said locality vested or administered by the local government for any of those purposes.

One option for the expenditure of the cash-in-lieu funds available would be to purchase additional land for POS. However, this is considered to be ineffective use of the funds. POS has already been allocated in each of the suburbs from where cash-in-lieu funds have been collected (Millars Well, Baynton, Baynton West and Nickol). This POS allocation is largely focused on larger parks and recreation grounds that are accessible to residents of the surrounding suburb. This is an efficient way to plan and maintain POS. No additional land has been identified for POS in any of these suburbs.

In addition to these parks and recreation grounds, the network of Drainage Reserves that link these suburbs present an opportunity to enhance the open space network. Cattrall Park is an example of a section of Drainage Reserve that has been developed to provide additional recreational space. Because these Drainage Reserves run across each of the suburbs, they provide opportunities to create linkages and trails for pedestrians and cyclists to the main destinations of these suburbs (ie. schools, parks and shopping centres).

Millars Well Cash-in-Lieu Funds

The City has received and is holding in Trust cash-in-lieu funds to the value of \$232,566 from Millars Well subdivisions. It is considered desirable to allocate this funding towards implementation of the Kevin Richards Memorial Oval Masterplan. This is the main recreational space in the area, it is within reasonable proximity of the subdivisions from where funds were collected, and redevelopment is identified as a project/action in Council's adopted Operational Plan 2019/20.

If Council supports expenditure of these cash-in-lieu funds on this project, then the cash-in-lieu funds can be directed to the following works set out under the Masterplan:

- Redevelopment of the pavilion;
- New sports change room;
- Sports lighting upgrade; and
- Redevelopment of the current playground.

Baynton, Baynton West and Nickol Cash-in-Lieu Funds

In addition to the cash-in-lieu funds held for Millars Well, the City has received and is holding in Trust cash-in-lieu funds to the value of \$621,267 from subdivisions in Baynton, Baynton West and Nickol.

There are a number of options to consider in terms of allocating this funding:

1. Purchase and develop additional land for POS in these suburbs;
2. Develop additional land for POS in these suburbs;
3. Upgrade existing parks, recreation grounds and/or open spaces within each of these suburbs.

The combination of Recreation and Drainage Reserves in each of these suburbs represents a large amount of open space that can potentially be used. In addition, there is not much land left in these suburbs that could be purchased and developed for POS. Accordingly, there is no need to purchase additional land for POS.

There are examples of portions of Drainage Reserves that have been developed as POS and sections that form part of the footpath network. However, the majority of the Drainage Reserve areas are currently not usable for recreation. There are many opportunities to develop additional portions of Drainage Reserves for POS in each of the suburbs.

While the parks, recreation grounds and open spaces in Baynton, Baynton West and Nickol are of a high standard, there are always opportunities to upgrade them. The constraint in accessing cash-in-lieu funds for the development of Portions of Drainage Reserves or upgrades to existing parks, recreation grounds and/or open spaces is that the funds can only be spent in the locality from where the funds have been collected. In other words, the \$621,267 would need to be divided up, with respective portions spent in the different areas.

The Baynton, Baynton West and Nickol POS contributions could be spent on a range of activities including:

- Upgrading existing parks, ovals and playgrounds within the suburbs
- Upgrading pathways, linkages and/or lighting in public spaces in these neighbourhoods
- Developing drainage reserves to become more usable POS (like has been done in Catrall Park).

While there are options for the potential expenditure, unlike Millars Well, there is no fully scoped, development ready project in this location. Given this, it is not recommended that the Baynton, Baynton West and Nickol POS be accessed at this point in time. Officers are planning to undertake further work and community consultation on this matter prior to making a recommendation to Council on the recommended use of the \$621, 267 of available funds

The process for making the cash-in-lieu funds available for expenditure is as follows:

1. The City submits a formal request to the WAPC for the expenditure of cash-in-lieu, accompanied by the required information under Planning Bulletin No. 21 – see Policy Implications for required information;
2. The WAPC will refer the proposal to the Minister for Planning for their consideration;
3. Should the Minister grant approval for the expenditure of cash-in-lieu funds, the City will be able to allocate the funds towards implementation of the Kevin Richards Oval Masterplan, and the enhancement of the western Karratha POS corridor.

LEVEL OF SIGNIFICANCE

In accordance with Council Policy CG-8 Significant Decision Making Policy, this matter is considered to be of moderate significance in terms of social, economic, environmental, cultural & wellbeing issues/Council’s ability to perform its role.

COUNCILLOR/OFFICER CONSULTATION

Consultation has taken place between Planning Services, Infrastructure Services, Community Services and Financial Services.

COMMUNITY CONSULTATION

There will continue to be community engagement as part of implementing the Kevin Richards Memorial Oval Masterplan. Community engagement activities in accordance with the iap² public participation spectrum process to inform, consult, involve, collaborate and empower are proposed as follows for expenditure of the Baynton, Baynton West and Nickol cash-in-lieu funding:

STATUTORY IMPLICATIONS

Section 154 of the *Planning and Development Act 2005* provides that cash-in-lieu funds received by the local government must be paid into a separate (trust) account. Under the *Local Government Financial Management Regulations 1996*, the account should clearly set out the purpose for which the money is held, the landholding from which it was obtained and the date on which it was paid to the local government.

POLICY IMPLICATIONS

Under WAPC Planning Bulletin No.21 (April, 1997), cash-in-lieu funds may, with the approval of the Minister for Planning, be used for the improvement or development as parks, recreation grounds or open spaces generally of any land in the said locality vested or administered by the local government for any of those purposes.

Under Planning Bulletin No.21, requests to the Minister for Planning for the expenditure of cash-in-lieu should be submitted to the WAPC and should be accompanied by a map and schedule showing:

- the location and WAPC reference number of the subdivision from which the funds were obtained;
- the dollar value of funds obtained from the subdivision;
- the location of the proposed reserve where the funds are proposed to be expended;
- the nature of the proposed expenditure; and
- the program for the expenditure of the funds

FINANCIAL IMPLICATIONS

If Council resolves to request Ministerial approval to the expenditure of cash-in-lieu funds, then those funds would only be able to be expended once Ministerial approval has been granted.

Trust funds are not recorded on the City’s balance sheet. Once Ministerial approval is granted to the expenditure of Trust funds, the funds are recorded as income. Expenditure of this funding would then be allocated to the relevant project expense account.

FORWARD to the Western Australian Planning Commission for the Minister for Planning's approval, the Kevin Richards Memorial Oval Masterplan, and the associated estimated costs to support the request for approval to spend \$232,565.97 cash-in-lieu contribution on development of the Kevin Richards Memorial Oval;
3. SEEK community input regarding cash-in-lieu of Public Open Space funds available for Baynton, Baynton West and Nickol and the limitations and options for expenditure of that funding;
4. REQUEST the Minister for Planning's approval to expenditure of contribution for the enhancement of the existing public open space corridor running between Nickol and Baynton, if generally supported by and as refined following community input;
5. FORWARD to the Western Australian Planning Commission for the Minister for Planning's approval, the concept plan for the upgrade of the existing public open space corridor and associated estimated costs to support the enhancement of the existing public open space corridor running between Nickol and Baynton.

Option 3

That Council by SIMPLE Majority pursuant to Section 3.18 of the *Local Government Act 1995* RESOLVES to NOT REQUEST the Minister for Planning approve expenditure of cash-in-lieu of public open space contribution towards implementation of the Kevin Richards Oval Masterplan, and the expenditure of cash-in-lieu of public open space contribution for the enhancement of the existing public open space corridor running between Nickol and Baynton, in order to consider alternative options for the expenditure of the cash-in-lieu contributions held in Trust by the City of Karratha.

CONCLUSION

Implementing the Kevin Richards Memorial Oval Masterplan is a commitment under Council's adopted 2019/20 Operational Plan. The City is planning to expend considerable funds upgrading these recreational grounds. The allocation of cash-in-lieu funds of public open space funds collected from Millars Well subdivisions would assist in delivering the

project. It would also improve recreational facilities for all residents of Millars Well, including those within the subdivisions from where funds have been collected.

The further cash-in-lieu of public open space funding that has been received from subdivisions in Baynton, Baynton West and Nickol also needs to be spent. One option for expenditure of that funding is to enhance the pedestrian and cyclist links between Baynton, Baynton West and Nickol and the new Tambrey Neighbourhood Shopping Centre. It is considered that improving these pedestrian and cyclist links would improve the amenity for all residents in these suburbs. It is recommended that community input be sought regarding expenditure of this cash-in-lieu before a request for approval is made to the Minister.

OFFICER'S RECOMMENDATION

That Council by SIMPLE Majority pursuant to Section 3.18 of the *Local Government Act 1995* RESOLVES to:

- 1. REQUEST the Minister for Planning approve expenditure of \$232,565 cash-in-lieu of Public Open Space contribution towards implementation of the Kevin Richards Memorial Oval Masterplan;**

PURPOSE

To consider tendering Grounds Maintenance Services in the City's eastern areas.

BACKGROUND

In 2015, a Parks and Gardens (P&G) Service Review was undertaken identifying gaps in service delivery, potential service improvements and associated resource requirements. The outcome resulted in a series of recommendations to engage specialist contract skills, provide an increase in City staff and purchase specialist equipment designed to enhance the standards of presentation of P&G areas through improved maintenance programs.

The City has continued to construct and/or manage additional infrastructure across all towns that requires resources and specialist skills. Further growth is forecast including:

- Dampier Land Transfer including parks, foreshores, ovals, and streetscapes
- Significant asset renewal programs such as reticulation, street tree planting and landscape enhancements
- Foreshore redevelopment works, significantly in Dampier and foreshore works in other towns
- Drainage Reserve enhancements

At its August 2019 Ordinary meeting, Council endorsed a revised maintenance level of service for all current and proposed P&G areas in the City. This program establishes the guideline for Officers to formulate asset maintenance plans for each site including the resources, contracts and materials needed to maintain P&G areas.

The 2019/2020 P&G Budget has largely been developed around the proposed hierarchy and subsequent level of service including additional contractors and staff, however several new developments and current service delivery methods require review to ensure the service levels can be achieved.

To determine the most cost effective and efficient delivery method, Officers have completed a review of service delivery options for delivery of appropriate levels of service to existing, new and planned P&G developments. This includes:

- Increased contractors

- Increased staff numbers
- Redeployment of staff and engaged contractors (shared service delivery model)

To evaluate options, Officers completed a review of the works required to meet the maintenance level of service for existing sites and forecast future sites (E.g.: Dampier). Once complete, Officers considered the number of hours of work required, nature of the work, existing contracts in place, and local skills available if required.

In order to determine how best to deliver services, Officers then reviewed indicative contractor rates versus in-house staff, including staff travel time and specialist skills required to maintain the City’s P&G assets.

Comparison Hourly Rates (including staff, overheads, machinery and plant resources):

Activity	City Rate (Hr)	Contract Rate (Hr)
Mowing	98	85
Landscaping	96	75
Garden Maintenance	94	65
Reticulation Maintenance	104	80
Weed Control	126	110

A critical aspect of the review is the forecast additional 9,000 operational hours required to achieve the proposed P&G level of service. Noting that one FTE Outdoor staff equates to 2070 operational hours per annum, therefore 4.35 FTE could be required if the city was to service all areas using staff. Additionally several project timelines and the proposed Dampier Land transfer timing mean that not all resources are required immediately, with Officers identifying approximately 3,000 hours of maintenance and project work required until the Dampier land transfer occurs in 2020.

In order to plan to deliver the additional services, the following strategy is proposed:

- Increase reticulation staff by one, as it is a cost effective outcome and provides City controls over timely responses. This position has been included in the 2019/20 Budget
- Provide short term contracts to assist in maintaining the increased natural areas, particularly considering the travel time required by one staff to attend to multiple sites across all towns.
- Provide short term contracts to assist with playground maintenance activities to supplement the existing staff.
- Consider additional staff versus contracts for garden and open space maintenance including consideration to location based services.

Typically, the selection of contracted services is based on cost, productivity, available resources and risk to Council and the Community. Contracting of specialist skilled services with specific plant and equipment, compliments employing staff, providing the City with a more cost effective outcome. As part of the review, Officers identified that 1,014 hours out of a total of 6,009 hours for mowing and garden services delivered in Roebourne, Wickham and Point Samson was spent on unproductive travel time. The Eastern Corridor therefore presents a significant opportunity to consider contracting services. The rates for typical landscaping, reticulation and oval mowing services are competitive versus in-house rates and the costs of travel time for City officers is significant.

If Council agree to contract P&G maintenance works in the eastern areas, it is anticipated that the term would be for a 2 year period with 1+1+1 year contract extension options. This would allow sufficient time for a contractor to settle into a maintenance regime whilst

providing the City with the opportunity to manage performance, have flexibility to extend, or decide to re-test the market. The scope of services that would be proposed in the contract include:

- Mowing all turf areas
- Garden maintenance including roundabout and verge gardens
- Basic reticulation maintenance (sprinkler replacement etc.)

Further, if the proposal to contract the eastern areas was supported, the available staff hours could be redeployed in the delivery of maintenance and project works until the Dampier Lands transfer was finalised. Opportunities include:

- Airport landscape project - includes landside and airside landscaping
- DeWitt project - includes landscaping the intersection in lieu of contractors (Council had previously agreed to reject submitted tenders for these works)
- Dampier Foreshore – maintenance, post practical completion November 2019.

After the finalisation of the Dampier Land Transfer in 2020, the total Eastern Corridor reallocated hours could be directed to Karratha new areas and Dampier full time maintenance.

LEVEL OF SIGNIFICANCE

In accordance with Council Policy CG-8 Significant Decision Making Policy, this matter is considered to be of moderate significance in terms of economic issues and Council's ability to perform its role.

COUNCILLOR/OFFICER CONSULTATION

Council adopted a new Parks, Gardens and Open Spaces Levels of Maintenance Services at its August 2019 meeting. At that same time it was reported that the maintenance levels for new and proposed areas would need to be resourced, with Council to consider the most cost effective delivery options available, as now contained in this report.

COMMUNITY CONSULTATION

No community consultation has been required as the subject of this report is considered an operational function of the City.

Considering the result of the community survey, it seems evident that the community believe that resources allocated to maintain the City's P&G is an effective return on investment. To ensure the community rating and expectations do not reduce, resources and methods to maintain the growing P&G areas will need to be managed accordingly.

STATUTORY IMPLICATIONS

If Council agree to call tenders, Section 3.57 of the *Local Government Act 1995* and Part 4, Division 2 – Tenders for providing goods and services of the *Local Government (Functions and General) Regulations 1996* will be applicable.

POLICY IMPLICATIONS

Council policies CG12 Purchasing and CG11 Regional Price Preference are applicable.

The proposed selection weighting criteria is as follows:

FINANCIAL IMPLICATIONS

Council has allocated \$8,308,294 in its 2019/20 Budget for all costs associated with maintaining its parks and gardens areas. This is inclusive of 20 operational staff or approximately 41,400 hours that are allocated to jobs across the City. This report suggest that a further 9000 hours may be required over time to service additional sites plus Dampier once the land transfer process occurs, however this can be achieved through contracts including consideration to contracting the Eastern Areas and redeploying staff resources.

The following table outlines the labour cost comparisons for current management to eastern areas and forecasts the costs to maintain the additional areas Karratha/Dampier.

Location	Forecast Budget
Eastern areas – current labour cost	\$550,000
Eastern areas – estimated contract labour cost	\$380,000
Potential Saving	\$170,000
Karratha/Dampier (additional)	\$302,000
Net Increase	\$132,000

As outlined, contracting the ground maintenance services in eastern areas could achieve a potential saving up to \$170,000 per annum. These potential savings could be used to offset costs associated with the estimated increase cost to manage the mowing and garden maintenance to new areas throughout Karratha and Dampier, estimated at \$302,000 and resulting in a net impact of \$132,000. Council has included \$200,000 in the 2019/20 budget based on the forecasted Dampier and Karratha increased maintenance areas and an additional \$200,000 associated with the Dampier Lands Transfer.

It is noted that not only financial benefits can be achieved by a shared service method, but productivity gains are also predicted due to the reduction of travel time currently incurred by in-house staff resources.

STRATEGIC IMPLICATIONS

CONCLUSION

Given the increasing P&G areas, the cost of employing staff, ability to attract appropriately skilled staff and the unproductive costs in travel time which has been identified to service the Eastern Corridor, a shared service delivery method (in-house/contractor) is believed to be the most cost effective and productive method to ensure service delivery and current standards are maintained across existing and future P&G areas.

PURPOSE

To consider tenders for Pre-Cyclone Green Waste Verge Collection offered under RFT 44-18/19.

BACKGROUND

At its meeting on 20 May 2019, Council resolved to call tenders for pre-cyclone green waste only annual collection service for a period of three (3) years with two (2) x one (1) year extensions, and consider redeployment of City resources (staff, plant and machinery) in the development of the 2019/20 budget.

The scope of works included:

- A cost per tonne for green waste verge side collection from all non-commercial properties in all town sites within the City of Karratha boundaries, with all waste delivered to the 7 Mile Waste Disposal Facility.
- Provision of costings for service rates for post cyclone events, other natural extraordinary events, illegal dumping within the City boundaries and ad hoc general clean-up events.

Tenders were advertised on 24 July 2019 and closed on 9 August 2019.

Two (2) tenders were received by the closing date from:

- Karratha Earthmoving and Sand Supplies PTY LTD.
- T C Waste (WA) PTY LTD.

The tenders were evaluated by a three (3) person panel comprising of:

- Operations Coordinator
- Manager City Services
- Waste Services Office Supervisor

The tenders were first assessed for compliance with the tender documents. The tenders were then assessed against the qualitative criteria and associated weightings as approved by Council at its meeting in May 2019, as follows:

Criteria	Weighting
Relevant Experience	25%
Capacity to deliver	20%
Demonstrated Understanding	5%
Price	50%

The Regional Price Preference Policy was applied to one local tenderer.

After considering the tender submissions, the panel is recommending that the contract period be amended from 3 years + 1 + 1 year extension options, to 1 year + 2 + 2 year extension options. This proposal would reduce the City’s risk and provides flexibility to consider returning to an in-house program if delivery is deemed inadequate via contracted services. This approach has been confirmed by the recommended contractor.

A copy of the Evaluation Report is contained within the confidential section of the agenda.

LEVEL OF SIGNIFICANCE

In accordance with Council Policy CG-8 Significant Decision Making Policy, this matter is considered to be of moderate significance in terms of economic issues, environmental issues and Council’s ability to perform its role.

COUNCILLOR/OFFICER CONSULTATION

Officer consultation has taken place between Waste Services, Parks and Gardens, and Operations teams. A presentation was provided to Council at its Agenda Briefing session on 19 August 2019 detailing the redeployment of City resources across other areas of the City’s Operations.

COMMUNITY CONSULTATION

Community consultation is not required at this stage of the process.

Historically, the community have been consulted via annual advertising of pre-cyclone collection services. As the collection is intended to only involve green waste, a Communication Strategy has been developed to ensure the community clearly understand the intentions of the new service. The extensive plan includes residential flyer drop-off, advertising via; social media, the City’s website, and the local newspaper in addition to other media platforms.

STATUTORY IMPLICATIONS

Tenders were called in accordance with Section 3.57 of the *Local Government Act 1995* and associated regulations.

POLICY IMPLICATIONS

Policies CG12 – Purchasing and CG11 – Regional Price Preference are applicable.

FINANCIAL IMPLICATIONS

Council has a resource budget of \$360,691 allocated within the 2019/20 financial year to deliver the current service program. Estimated service cost of contract is \$110k. This indicative cost is based on green waste collection of 300 tonnes. Actual costs will be based on the tonnage collected and may vary from that estimated.

STRATEGIC IMPLICATIONS

This item is relevant to the Council’s approved Strategic Community Plan 2016-2026 and Corporate Business Plan 2016-2021. In particular, the Operational Plan 2019-2020 provided for this activity:

Council have previously agreed to contract services aligned to waste collection, sanitation and cleaning, and post cyclone green waste collection.

CONCLUSION

The Evaluation Panel believes that the recommended tenderer, T C Waste (WA) PTY LTD provides the most beneficial outcome to the City. It is however recommended that as this is the first time pre-cyclone green waste collection services has been offered to contract, that it be for a term of 1 year + 2 + 2 year extension options, providing both the contractor and the City opportunity to review the delivery of the service after a 12 month period before committing to a longer term contract. It is anticipated that the contract will commence on 7 October 2019.

PURPOSE

To consider tenders for the provision of Litter and Sanitation Services for the Eastern towns offered under RFT 41-18/19.

BACKGROUND

At its June 2019 meeting, Council agreed to call tenders for the provision of Litter Collection Services in Point Samson, Wickham and Roebourne including labour resourcing requirements for the efficient operation of the Wickham Waste Transfer Station. The following scope of works was proposed:

- **Scope One - Litter Picking Services**
The nominated Contractor will provide Litter Picking services and remove to the Wickham Waste Transfer Station. The Contractor will supply suitable and appropriate amount of staff and equipment as required to undertake all aspects of scheduled litter control duties on behalf of the City.
- **Scope Two – Sanitation Services**
Sanitation services will consist of cleaning and pressure cleaning/washing of structures, BBQ's, picnic shelters, bin enclosures, seating, drinking fountains, bike racks, bus shelters and hard stands associated with the above areas.
- **Scope Three – Waste Transfer Station Operatives, Staff Labour Hire Services**
The Contractor is responsible for providing resourcing at the Wickham Waste Transfer Station (WTS) as per the conditions of the facility licence conditions. Contracted staff will inspect, check, record and direct facility users to the appropriate disposal location, whilst performing general site duties including all garden maintenance and the transport of full and empty skips from the 7 Mile Waste Disposal Facility to the WTS. The WTS - Operational Management Plan will guide contracted staff to perform all required functions needed. City staff in consultation with the Contractor will oversee the supervision and training of all contracted staff.

Tenders were advertised on 20 July 2019 and closed 19 August 2019.

Three tenders were received by the closing date from:

- Diverse Group Australia
- Brida Pty Ltd
- Blue Hat Group Pty Ltd T/A Damel Cleaning Services

The tenders were evaluated by a 3 person panel comprising of:

- Manager City Services
- Waste Services Administration Supervisor
- Sanitation Supervisor

The tenders were first assessed for compliance with the tender documents. The tenders were then assessed against the qualitative weighted criteria as endorsed by Council as follows:

Brida Pty Ltd price submitted is within the allocated budget for this service.

RISK MANAGEMENT CONSIDERATIONS

The level of risk to the City is considered to be as follows:

IMPACT ON CAPACITY

The City currently employs 2 FTE staff from its Seven Mile Waste Disposal Facility to man the Wickham WTS during the week and a permanent 0.6 FTE to man the WTS over weekends and every second Friday. Redeployment options will be considered for the affected staff members.

RELEVANT PRECEDENTS

Council has previously engaged labour hire contractors for the provision of litter collection services offered under RFT 35-16/17 in April 2017 and RFT38-18/19 Karratha and Dampier Litter and Sanitation contracts in May 2019.

PURPOSE

To provide annual statistics from Development Services for the Council's information. The period reported on includes 01/08/2019 to 29/08/2019 (21 business days).

- The number of Development Applications received so far in 2019 is 25% higher than the whole of 2018.
- The construction value of Building Permits this year is approximately \$49m, compared with \$32.5m for the whole of 2018.
- Development Applications for the Ranges Workforce Accommodation and the Quarter Hotel will be reported to JDAP in September.
- The Minister for Planning has determined Scheme Amendment No.39 (Workforce Accommodation).
- There are 9 active Direction Notices under the *Planning and Development Act 2005*, and 6 court matters of which 4 are development related and 2 are dog attacks.
- Parking inspections are significantly less this period due to staff leave and an increased time spent on processing and management of dog attack incidents.
